Re: Guidance and Temporary Requirements for Post Hurricanes Recovery Efforts Applicable to Permittees with Coverage under the NPDES Small Municipal Separate Storm Sewer Systems General Permit for Stormwater Discharges Associated with Urban Storm Water Runoffs in Puerto Rico

Dear MS4 Permittee:

The purpose of this Notice is to advise permittees with coverage under the 2016 National Pollutant Discharge Elimination System (NPDES) Small Municipal Separate Storm Sewer Systems General Permit for Stormwater Discharges Associated with Urban Storm Water Runoffs (Small MS4 GP), located in the Commonwealth of Puerto Rico, that as a result of Hurricanes Irma and María (Hurricanes), the United States Environmental Protection Agency, Region 2 (EPA), is hereby providing temporary relief to permittees who are unable to meet certain requirements and conditions included in the Small MS4 GP. These Hurricanes caused, among other things, unprecedented damage and impairment to infrastructure, telecommunications (i.e., internet capability), electrical power services, drinking water distribution, and reduction in labor force. The EPA is the agency with the authority to administer the federal NPDES program within the Commonwealth of Puerto Rico. EPA maintains enforcement authority for violations of the federal Clean Water Act (CWA) and NPDES program regulations.¹

¹ Section 402 of the CWA, 33 U.S.C. § 1342, defines the National Pollutant Discharge Elimination System as the national program for, among other things, issuing and enforcing discharge permits. Section 402(a)(1) of the CWA, 33 U.S.C. § 1342(a)(1), provides that "the Administrator may, after opportunity for public hearing, issue a permit for the discharge of any pollutant...upon condition that such discharge will meet . . . such requirements as the Administrator determines are necessary to carry out the provisions of the [CWA]."

TO WHOM THIS NOTICE APPLIES:

This Notice applies to permittees with coverage under the Small MS4 GP. The EPA expects that

permittees will continue to follow and comply with the Small MS4 GP requirements (i.e. update the

stormwater management program (SWMP), implement minimum control measures (MCM)) and

conditions (i.e. performance of illegal detection and discharge elimination inspections, outfall

reconnaissance inventory and mapping) to the maximum extent practicable, and will continue to keep

those records (i.e. inspection reports, annual reports) that are necessary to satisfy the record-keeping

requirements of the Small MS4 GP.

EPA has developed a status list of entities with/without coverage under the Small MS4 GP and

requirement deadlines. For further information, see Attachment I.

Permittees, to the best of their ability, are still expected to submit records, as required by the Small MS4

GP, to EPA and the Environmental Quality Board (EQB) of Puerto Rico, when applicable, using whatever

services (i.e. mail, hand-delivery, electronic mail) are available. Permittees should have taken, and should

continue to take, all reasonable steps to minimize and prevent any discharge of pollutants which had or

has a reasonable likelihood of adversely affecting human health or the environment.

For those regulated Small Municipal Separate Storm Sewer Systems (MS4s) that have not sought coverage

under Small MS4 GP as of the date of issuance of this Notice, EPA advises that those MS4s shall make

every effort to submit a complete and accurate Notice of Intent for coverage under the Small MS4 GP as

soon as practicable, as well as follow and comply with the Small MS4 GP requirements (e.g. develop and

implement a SWMP and MCM) to the maximum extent practicable, and document progress with annual

reports, outreach efforts and inspection assessments.²

GENERAL REQUIREMENTS:

In each instance where the permittee determines that it is necessary to submit information or required

documents (as set forth below) later than the date set forth in the Small MS4 GP, such submission must

include a certification that the late submission is a direct consequence of the Hurricanes, as well as an

explanation of why the requirement could not be met. All delayed submissions made pursuant to this

Notice shall be in English, signed by an authorized official, and include the following certification:

"I certify under penalty of law that this document and all attachments are submitted late or

after its due date because post-Hurricane conditions made it impracticable or unfeasible to

meet the Permit requirements, notwithstanding having made every good-faith effort to

meet such Permit deadlines. These documents were prepared under my direction or

supervision. The information submitted is, to the best of my knowledge and belief, true,

accurate, and complete. I am aware that there are significant penalties for submitting false

information, including the possibility of fines and imprisonment for knowing violations."

For those Small MS4 GP requirements that were not met because of the Hurricanes, permittees must

submit to EPA a detailed description of the Small MS4 GP requirement, as well as a detailed justification

of why the requirement was not met.

This Notice should not be construed as a no-action assurance by EPA. EPA retains its enforcement

authority or any other authority pursuant to the CWA, which EPA shall exercise solely at its discretion,

as provided for the CWA.

NON-NUMERIC EFFLUENT LIMITATION:

EPA recognizes that due to the extreme wind and flooding conditions caused by the Hurricanes, MS4s

could have suffered direct and/or indirect damage to MCM and/or Best Management Practices (BMPs),

such as structural controls, which are required to be implemented, inspected and maintained, to satisfy the

requirements of Part 2 of the Small MS4 GP. In those instances, the permittee must evaluate and document

the damage and operation status, and repair and/or replace the BMP in accordance with good engineering

practices and manufacturer's specifications.

In the situation in which the permittee will not be able to repair and/or replace the BMP by June 30, 2018,

the permittee must send a notice to EPA describing the BMP in need of repair and/or replacement and an

implementation schedule. EPA advises that any such implementation schedule shall not exceed December

31, 2018. In those instances in which the implementation schedule may exceed December 31, 2018, the

permittee shall contact EPA for further guidance, using the EPA contact information provided below in

this Notice.

STORM WATER MANAGEMENT PROGRAM:

Permittees are required to modify/update their existing SWMP, and enhance the document to incorporate

the Small MS4 GP conditions in accordance with Part 2 of the Small MS4 GP. This modified/updated

SWMP is to be submitted within one (1) year of the date of authorization of coverage, as required in Part

2.3.1 of the Small MS4 GP. EPA recognizes that permittees have filed their Notice of Intents (NOIs) and

have been granted coverage on different dates under the Small MS4 GP. As such, each permittee has a

unique date to submit to EPA its modified/updated SWMP. Those permittees that were required to submit

to EPA a modified/updated SWMP after the Hurricanes, during the period from September 6, 2017 to

April 30, 2018, are allowed to submit the modified/updated SWMP by June 30, 2018.

Those first-time permittees that were granted coverage under the Small MS4 GP between September 6,

2017 and December 31, 2017, are also allowed to submit the SWMP by June 30, 2018.

ANNUAL REPORT:

Once permittees are covered under the 2016 Small MS4 GP, permittees must submit to EPA annual

reports, as required by Part 3.4 of the Small MS4 GP. Permittees are required to submit the annual report

to EPA by July 30th of each year. The annual report must contain information generated from July 1st to

June 30th of the past calendar year, except that the first annual report covers additional time.³ This

requirement is directly dependent on the performance and documentation of the implementation of the

SWMP in Part 2.4 of the Small MS4 GP.

Based on the Small MS4 GP requirements set forth above in this Notice, EPA is extending the requirement

to submit the annual report. The annual report, including the information obtained from the program

implementation assessment performed from July 1, 2017 to June 30, 2018, is due by September 30, 2018.

³ Part 3.4.1 indicates that the reporting period will be a one-year period commencing on the authorization date, and subsequent anniversaries thereof, except that the first annual report shall also cover the period from November 6, [of the last report] to the

authorization date.

RECORD KEEPING:

Part B of Appendix B.10 of the Small MS4 GP establishes the record keeping requirements that permittees

must follow. EPA recognizes that records could have been lost and/or damaged due to the Hurricanes. In

those instances in which the permittee suffered record loss and/or damages, the permittee must perform

an evaluation of the records required to be maintained and document any loss or damage in the SWMP.

This evaluation and documentation must be completed by June 30, 2018.

BY-PASS AND UPSET:

The EPA advises the permittees that the NPDES regulations at 40 C.F.R. §§ 122.41(m) and (n), as well

as the Small MS4 GP, provide for "bypass" and "upset" conditions. The permittee must be aware of these

regulatory and permitting requirements, and submit, where applicable, notices conforming to the

regulations and permit requirements. EPA will be accepting complete and accurate notices and

notifications concerning bypass and upset through May 31, 2018.

OTHER PERMIT CONDITIONS AND REQUIREMENTS:

In the event that a permittee did not meet or will not meet a condition or requirement of the Small MS4

GP between September 6, 2017 and June 30, 2018, the permittee shall submit to EPA a notice in

accordance with 40 C.F.R. § 122.41(1)(7) and the Small MS4 GP no later than July 31, 2018. In those

instances, or in the situation in which the permittee will not meet a condition or requirement of the Small

MS4 GP beginning on July 1, 2018, the permittee shall submit a notice to EPA according to 40 C.F.R. §

122.41(1)(2).

NPDES PERMIT HOLDERS SUBJECT TO ENFORCEMENT ACTIONS UNDER SECTION 309

OF THE CWA, 33 U.S.C. § 1319:

Certain entities are currently subject to compliance and enforcement actions that incorporate compliance

schedules and "Force Majeure" conditions. Those permittees must be aware of the "Force Majeure"

requirements in the enforcement documents (i.e., administrative order on consent, Consent Decrees), and

submit required notifications in accordance with the requirements of the actions. In those instances in

which the permittee was unable to submit a non-compliance notification or force majeure notice in

accordance with the requirements of the action, the entity shall contact José A. Rivera, BSCE, Team

RESERVATION OF RIGHT:

Notwithstanding the Guidance and Temporary Requirements described above, EPA reserves its right to exercise enforcement authorities where appropriate and pursuant to the provisions of the CWA.
