**PUBLIC NOTICE**

**AMENDMENTS TO THE CONSOLIDATED HOUSING AND COMMUNITY DEVELOPMENT PLAN 2018-2022 AND THE ANNUAL PLAN OF THE YEAR PROGRAM 2019-2020, PER CDBG-CV3 FUND ALLOCATION**

The Autonomous Municipality of Guaynabo informs the citizens, and all interested parties that it intends to amend the Action Plan 2019-2020 of the CDBG program, which corresponds to the Consolidated Plan of Housing and Community Development 2018-2022. The purpose of the amendment is to recognize additional Community Development Block Grant funds allocated to the Municipality as part of the CARES Act (CDBG-CV3). This amendment is addressed in accordance with the Citizen Participation Plan of the Municipality, as amended and to FR-6218-N-01 of August 10, 2020, in reference to allocations and flexibilities adopted due to the COVID-19 Pandemic and under the CARES Act.

Below, we detail the activities that are proposed to be added to the Annual Plan by means of this amendment (it is clarified that this notice replaces and cancels the recently published amendment notice for amendment to the 2020-2021 Annual Plan regarding these same concepts):
