**AMENDMENTS TO THE CONSOLIDATED HOUSING AND COMMUNITY DEVELOPMENT PLAN 2018-2022
AND THE ANNUAL PLAN OF THE YEAR PROGRAM 2020-2021, PER CDBG-CV3 FUND ALLOCATION**

The Autonomous Municipality of Guaynabo informs the citizens, and all interested parties that it intends to amend the Action Plan 2020-2021 of the CDBG program, which corresponds to the Consolidated Plan of Housing and Community Development 2018-2022. The purpose of the amendment is to recognize additional Community Development Block Grant funds allocated to the Municipality as part of the CARES Act (CDBG-CV3). This amendment is addressed in accordance with the Citizen Participation Plan of the Municipality, as amended and to FR-6218-N-01 of August 10, 2020, in reference to allocations and flexibilities adopted due to the COVID-19 Pandemic and under the CARES Act.

Below, we detail the activities that are proposed to be added to the Annual Plan by means of this amendment:
